#### Value of Small

(Sheffield University led research)

- Vital part of everyday life but more likely to be adversely affected by cuts to public sector budgets
- Distinctive offer
  - First responders; hyper-local; offer safe spaces; inclusive & promote belonging
- Distinctive approach
  - Person centred and responsive; embedded, trusted & long term presence; open door & non-judgemental; quick decision-making.
- Distinctive position
  - Extent & nature of local networks & relationships; stabilising role ('the glue'); and, undertake advocacy work for the individuals.

### Added Value

- Use more volunteers local and with 'lived' experience
- Funding leverage (attract resources into the locality)
- Embeddness in local organisational and social networks



# Part Two: Lobbying for resources

- Managed by CVS Community Fund
- Up to £500 revenue; up to £500 equipment
- Deadlines for next rounds:
  - 15<sup>th</sup> July 2019 12.00 noon
  - 23<sup>rd</sup> September 2019 12.00 noon
- Overall pot: £60,000

## Local: Big Local Shadsworth with Whitebirk

(volunteer only groups: no paid staff)

- Grants up to £1000
- Deadlines
  - Friday 5<sup>th</sup> July 2019; Friday 06<sup>th</sup> September 2019
  - Friday 08<sup>th</sup> November 2019; Friday 10<sup>th</sup> January 2020
- Total Pot available: £18,000

#### Local: Brian Mercer Charitable Trust

- Normal Grant Size: around £10k
- Give £80k per year to Blackburn causes also fund the arts (£120k per year) and prevention of human suffering (£600k per year).

# Local: WEA ESF Community Grants

- Grants up to £20,000 (total amount £782k for Lancashire)
- Focus: supporting people to improve their employability
- Organisation Size: less than 12 FTE staff & £500k turnover; operating minimum of 12 months
- Deadlines
  - Round 2 (August 2019); Round 3 (Jan 2020); R4 (Apr 2020)

- Focus: promoting human rights; poverty prevention; tackling discrimination
- Grants up to £2k or £20k for registered charities
- Deadlines
  - Round 2 Stage 1 14<sup>th</sup> August 2019 4pm
  - Round 2 Stage 2 25<sup>th</sup> September 2019 4pm

# National: Henry Smith Charity

- Grants: £20k to £60k per annum (for 3 years)
- Focus: Improving Lives or Strengthening Communities
- Organisational Size £50k to £2million
- Deadlines
  - No deadlines but responses in 6 months

- Grant amount: up to £10k per year for 3 years
